◆ OPEN ACCESS STATEMENT

AMRJ is an open-access journal which aims to provide access to scholarly articles. Readers are allowed to copy, distribute, download, print, read, search, or link to the full texts of the articles without asking for any prior permission from the author or publisher.

The full text of all content is available freely without delay, with **no embargo period** and registration required to read the available content.

Content Copyright Policy

The work published by AMRJ is licensed under a [Creative Commons Attribution-Non-Commercial 4.0 International \(CC BY-NC 4.0\)](#).

The work published in AMRJ may be “shared, copied and redistributed in any medium or format” and “adapt, remix, transform, and build upon the material.” Authors retain the rights of free downloading/unlimited e-print of full text and a/disseminating the article without restriction, including scholarly collaboration networks like Google Scholar, LinkedIn, Academia.edu, ResearchGate, Twitter, Facebook and any other professional or academic networking site.

◆ PEER-REVIEW POLICY

Initial Assessment and Editorial Oversight

At the AMRJ, submitted contributions undergo a meticulous review to assess their adherence to submission guidelines. Following this initial screening, the submission is forwarded to an editor for a comprehensive evaluation of its suitability for peer review. To ensure impartial judgment, cases where conflicts of interest arise, such as an editor’s affiliation with an article, prompt the assignment of an alternate editorial board member to oversee the peer-review process. While

peer-review reports undoubtedly influence editorial decisions, the ultimate determination rests with the editors, who retain full autonomy to make unbiased judgments. It's important to highlight that a single concern raised, whether by a peer reviewer or editor, can lead to the rejection of the paper. The outcomes of the peer review, coupled with the editorial decision, are communicated expeditiously to the authors.

Double-Anonymized Peer Review

To uphold the principles of fairness and objectivity, the AMRJ strictly adheres to a double-anonymized peer-review policy for all submissions. Authors are kindly urged to meticulously remove any identifying information, including names, affiliations, and acknowledgements, from their manuscript before submission. This proactive measure significantly contributes to preserving the integrity of the peer-review process. Peer reviewers, chosen for their subject expertise, are responsible for maintaining confidentiality regarding the manuscript's content. Furthermore, reviewers are explicitly instructed to uphold the anonymity of the author(s) during the review process. In cases where potential conflicts of interest arise during the review, reviewers are promptly expected to notify the editorial board.

Confidentiality and Compliance

Preserving confidentiality is a foundational pillar of the peer-review process at the AMRJ. It is non-negotiable that authors and reviewers strictly adhere to these established confidentiality guidelines, guaranteeing the process's credibility. Any breach of confidentiality—such as inadvertent disclosure of identities or sensitive details—may have serious consequences, including the rejection of the manuscript or other appropriate actions deemed necessary. Authors who submit to the AMRJ must be agreed to these policies and are urged to steadfastly uphold the standards of confidentiality. This collective commitment reinforces a robust and reliable peer-review system.

Time Frame

Considering the authors' time and the urgency of scholarly dissemination, the AMRJ prioritizes an efficient review process. Following the initial assessment, manuscripts seamlessly transition

to the peer-review phase. Peer reviewers are allocated a dedicated period of **two to four weeks** to conduct their evaluations. When a reviewer's response is delayed beyond this timeframe, alternative reviewers are promptly engaged to ensure minimal disruption and timely progress. This strategic approach aims to curtail delays and sustain the momentum of the review process, ultimately facilitating a streamlined publication journey for authors.

◆ PEER-REVIEW POLICY

Allied Medical Research Journal is committed to advancing the dissemination of valuable research under the [Creative Commons Attribution-Non-Commercial 4.0 International \(CC BY-NC 4.0\)](#) license, which grants readers unrestricted and free access to scholarly articles while permitting content reuse by attributing the original authors.

AMRJ is aimed to facilitate knowledge sharing while maintaining the sustainability of our high-quality publishing services. The Article Processing Charges (APCs) collected from authors for accepted manuscripts help cover the costs associated with publication and the upkeep of our open-access platform. This model enables us to uphold excellence and accessibility, aligning with our mission to provide open and equitable access to valuable research for the benefit of both the scientific community and the broader public.

Articles Types and APC's

1. Case Report, Case Series, Original Researches, Reviews, and Short Communications

National Contributors (Pakistan)

- **Publishing Charges:** PKR 15,000 (For accepted articles after successful peer review)
- **Fast Track Charges:** PKR 30,000 (For expedited review and publication)

International Contributors (Outside Pakistan)

- **Publishing Charges:** USD 200 (For accepted articles after successful peer review)
- **Fast Track Charges:** USD 300 (For expedited review and publication)

2. Editorials, Corrections, Addendums, Retractions, Comments

No charges for these article types.

Fast-Track Submission for Rapid Peer Review

AMRJ offers a fast-track submission option for authors requiring expedited manuscript handling:

Key Features

- Accelerated peer review and publication.
- Rapid peer review within 2 weeks.
- Editorial decision within 4 weeks.
- Manuscripts published in upcoming issues.

Submission Steps

1. Prepare your manuscript according to the guidelines.
2. Complete the **Fast-Track Submission Request Form**.
3. Upload the manuscript and form on online journal system.
4. Pay a nominal fast-track fee.
5. Manuscript undergoes expedited peer review; decision in 4 weeks.

Note:

- Fee waivers for authors are not currently available for any article.
- There are no submission charges for authors.
- Upon acceptance, payment instructions for online transactions will be emailed to the corresponding author.

- No submission charges or rejection fees apply to authors for standard and fast-track submissions.

◆ PUBLICATION AND RESEARCH ETHICS

When reporting experiments on human subjects, authors should indicate whether the procedures followed were by the ethical standards of the responsible committee on human experimentation and with the latest version of the Helsinki Declaration. In text and illustrative material, do not use patients' names, initials, or hospital numbers. Every manuscript submitted to AMRJ should be approved by the organization's ethical review committee (ERC) or Institutional review board (IRB). A study having National Clinical Trial Number will be preferred. The statement should be written on the official letterhead of the ERC or IRB, duly stamped and signed by the committee's chairperson. The study should be approved prospectively. Studies not involving direct contact with human subjects would require submission of an exemption letter issued by the institutional ERC/IRB before the project's starting date. Suppose an institution does not have an ethical review committee, in that case, approval should be sought from another institution adhering to ethical norms and governing research involving humans using ethical review committees willing to cooperate to enhance ethical standards. AMRJ follows the guidelines of the [Committee on Publication Ethics](#) (COPE) and suggests the author must adhere to these guidelines for manuscript submission

◆ PLAGIARISM POLICY

AMRJ follows the [International Committee of Medical Journal Editors](#) (ICMJE) and [Higher Education Commission](#) (HEC) guidelines/criteria for all types of plagiarism. All the submitted manuscripts are subjected to plagiarism checking through the software 'Turnitin'. Manuscripts with a more than 19% similarity index are only processed further if rectified. The plagiarized manuscript presented with extensive copy-pasted data or another's work without crediting the source is inappropriate and would not be considered for publication in AMRJ. The

author must apprise themselves of plagiarism in any form, including paraphrasing and self-plagiarism. To authenticate originality, manuscripts submitted to AMRJ can be sent to HEC, other medical journals' editors, and international agencies. The disciplinary committee of AMRJ would deal with cases of plagiarism and comprise the staff, editors, and the chief editor or representative. For a plagiarized article (multiple submissions) in processing, the identification of the act will lead to dropping the article from further processing/consideration of publication.

◆ ANIMAL STUDIES

AMRJ accepts animal studies only when the Animal Ethics Committee (AEC) of the institution provides ethical approval.

◆ CONFLICT OF INTEREST

A sample definition by [the World Association of Medical Editors](#) (WAME) states that “conflict of interest exists when a participant in the publication process (author, peer reviewer, or editor) has a competing interest that could unduly influence (or be reasonably seen to do so) his or her responsibilities in the publication process.”

All authors should declare any conflict of interest, which may include grants or honorarium, credits and promotions, memberships or any personal or professional relationships, and data ownership rights of the academic or clinical units where the study was conducted, which may appear to influence the manuscript or deny due credit to the study site. Such competing interests may not be unethical but may be considered a questionable research practice.

◆ SCIENTIFIC MISCONDUCT

AMRJ follows the guidelines provided by the [Committee on Publication Ethics](#) (COPE), the [World Association of Medical Editors](#) (WAME), the [International Committee of Medical Journal Editors](#) (ICMJE) and the [Higher Education Commission, Pakistan](#) (HEC) for dealing with scientific misconduct.

◆ WITHDRAWAL POLICY

According to AMRJ's copyright policy, the copyright belongs to the journal upon manuscript submission. Moreover, submitting the same manuscript to more than one journal simultaneously is considered unethical.

If the authors want to withdraw the manuscript during its processing, an email has to be sent notifying their intention. A final letter from the editorial office for the withdrawal of the manuscript will be sent to confirm the withdrawal. Please note that without a formal withdrawal email, a manuscript is not considered withdrawn, and the use of such a manuscript elsewhere will be construed as ethical misconduct.

◆ REPOSITORY POLICY

All manuscripts published in the AMRJ will be meticulously archived and made readily accessible from the journal website, benefiting both authors and readers under the following approaches:

AMRJ operates as an open-access journal, ensuring that manuscripts are made promptly available online upon completion **without any embargo period**. Authors maintain the right to make their articles publicly available per the terms outlined in the CC BY-NC 4.0 license.

Authors published under the [CC BY-NC 4.0 license](#) can distribute and disseminate their articles across non-commercial websites and reputable repositories.

Reuse Guidelines for Open-Access Content

In the event of reposting, distributing, or reusing open-access articles originating from AMRJ, it is paramount to acknowledge the journal as the primary source of publication and provide precise citation information. Authors must deposit the Uniform Resource Locator (URL) and the Digital Object Identifier (DOI) of their published article within any designated repository.

Furthermore, authors are strongly encouraged to ensure that the Version of Record (VOR) is available within repositories, aligning with the open-access license terms. This practice guarantees that the authoritative version is effortlessly accessible to individuals utilizing repositories and consequently enhances the accuracy of citations.

Authors can disseminate their work through a wide array of formats:

- **Author's Original Manuscript (AOM)**

The Author's Original Manuscript (AOM) symbolizes the initial submission preceding the peer review process. Authors can share their AOM via various mediums, such as social media, scholarly collaboration networks, and personal websites marked for non-commercial usage. However, upon formal publication, authors are kindly requested to impart the article's published status, accompanied by its DOI and corresponding web link.

- **Accepted Manuscript (AM)**

The Accepted Manuscript (AM) embodies the version that has triumphantly traversed the rigors of peer review and obtained the endorsement of the journal's editorial board. Authors are at liberty to disseminate their accepted manuscripts, contingent upon the explicit indication of the article's status as "accepted" and the inclusion of the DOI.

- **The Version of Record (VOR)/Published Article**

The Version of Record (VOR) or Published Article epitomizes the definitive and citable form of the paper. This version has undergone meticulous copyediting, typesetting, and metadata application and has been attributed to a Digital Object Identifier (DOI). It stands as the ultimate version that has been officially published.
