

OPEN ACCESS POLICY

Allied Medical Research Journal provides free, unlimited access to the full text of its articles to ensure rapid dissemination and easy accessibility. Users requires no permission for scholarly or commercial use of the published articles, but are expected to acknowledge Allied Medical Research Journal as the original source. By submitting their work for publication, authors grant Allied Medical Research Journal a non-exclusive right to reproduce, publish, and communicate their work or any part of it to the public in any medium for educational or other purposes. In addition to the Author's moral rights in respect of the work, the author(s) retains the right according to CC BY 4.0.

PEER-REVIEW POLICY

All contributions to the Allied Medical Research Journal are checked for completeness first, and only after that are they sent to be evaluated by an editor who determines if they are appropriate for peer review. Another member of the Editorial Board will be designated to supervise peer review in cases where an Editor is listed as an author or has any other competing interests with respect to a particular article. Editors will take the peer-reviewed reports into account when making a choice, but they are not required to follow any advice given in them. A single peer reviewer's or the editor's concern could lead to the paper being rejected. Peer review findings and the editorial judgment on a paper are sent to the authors.

Allied Medical Research Journal has a policy of double-anonymized peer review for all submissions. This means that the identities of both the authors and the peer reviewers will be kept confidential throughout the peer review process. Authors are requested to ensure that their submissions do not contain any identifying information such as their name, affiliation, or acknowledgments. Any identifying information should be removed from the manuscript before submission. Peer reviewers are selected based on their expertise and are asked to keep the content of the manuscript confidential. They are also requested to maintain the anonymity of the author(s) throughout the review process. If any potential conflict of interest arises during the review process, reviewers should immediately inform the editorial board. Allied Medical Research Journal takes confidentiality seriously and expects all authors and reviewers to adhere to these guidelines. By submitting to Allied Medical Research Journal, authors agree to these policies and understand that any breach of confidentiality may result in the manuscript being rejected or further action taken.

PUBLICATION AND RESEARCH ETHICS

When reporting experiments on human subjects, authors should indicate whether the procedures followed were in accordance with the ethical standards of the responsible committee on human

Experimentation and with the latest version of Helsinki Declaration. Do not use patients' names, initials, or hospital numbers, in text and illustrative material. Every manuscript submitted to

AMRJ should have the ethical approval by the ethical review committee (ERC) or Institutional review board (IRB) of the organization. Study having National Clinical Trial Number will be preferred. The statement should be written on the official letterhead of the ERC or IRB duly stamped and signed by the Chairperson of the committee. The study should be approved prospectively. Studies not involving direct contacts with human subjects would require submission of an exemption letter issued by the institutional ERC/IRB before the starting date of the project. If an institution does not have an ethical review committee, the approval should be sought from another institution adhering to ethical norms and govern research involving humans by means of Ethical Review Committees that are willing to cooperate in the enhancement of ethical standards. AMRJ follows the guidelines of [Committee on Publication Ethics](#) (COPE) and suggest the author must adhere to these guidelines for manuscript submission

PUBLICATION AND COPYRIGHT POLICY

Authors who publish with Allied Medical Research Journal retain unrestricted copyright to their submissions and can use their work in any manner they choose, including republishing it in different forms, such as online, in books, popular science articles, or similar, once it has been published in the journal.

When republishing their work, authors are requested to provide AMRJ credit; this is optional but appreciated. By submitting an article for publication in AMRJ, the author grants Journal an unlimited permission to publish the article under the journal's appropriate creative common license in the journal, online, and in the journal's archive.

Also, the author consents to the publication of their work in AMRJ and to the journal's use of it for promotion.

PLAGIARISM POLICY

AMRJ follows the [International Committee of Medical Journal Editors](#) (ICMJE) and [Higher Education Commission](#) (HEC) guidelines/criteria for all types of plagiarism. All the submitted manuscripts are subjected to plagiarism checking through the software Turnitin. Manuscripts with a similarity index of more than 19% are not processed further unless rectified. The plagiarized manuscript that is presented with large copy-pasted data or another's work without crediting the source is inappropriate and would not be considered for publication in AMRJ. It is the authors' responsibility to apprise themselves of plagiarism in any form including paraphrasing and self-plagiarism. Manuscripts submitted to AMRJ can be sent to HEC, other medical journals' editors, and international agencies for authentication of originality. The disciplinary committee of AMRJ would deal with cases of plagiarism and comprise of the staff, editors, and the Chief Editor or his representative. For a plagiarized article (multiple submissions) in processing, the identification of the act will lead to the dropping of the article from further processing/consideration of publication.

ANIMAL STUDIES

AMRJ accepts animal study only when ethical approval is provided from Animal Ethics Committee of the institution.

CONFLICT OF INTEREST

A sample definition by [World Association of Medical Editors \(WAME\)](#) states that conflict of interest “exists when a participant in the publication process (author, peer reviewer, or editor) has a competing interest that could unduly influence (or be reasonably seen to do so) his or her responsibilities in the publication process.”

Any conflict of interest should be declared by all authors. This may include grants or honorarium, credits and promotions, memberships or any personal or professional relationships, data ownership rights of the academic or clinical units where the study was conducted, which may appear to influence the manuscript or deny due credit to the study site.

Such competing interests may not be unethical, but may be regarded as a questionable research practice.

SCIENTIFIC MISCONDUCT

AMRJ follows the guidelines provided by the [Committee on Publication Ethics \(COPE\)](#), the [World Association of Medical Editors \(WAME\)](#), the [International Committee of Medical Journal Editors \(ICMJE\)](#) and the [Higher Education Commission, Pakistan \(HEC\)](#) for dealing with scientific misconduct.

WITHDRAWAL POLICY

According to AMRJ's copyright policy, the copyright belongs to the Journal upon submission of the manuscript. Moreover, it is considered unethical to submit the same manuscript to more than one journal at the same time.

If the authors want to withdraw the manuscript during its processing, an email has to be sent notifying their intention. A final letter from the editorial office for withdrawal of the manuscript will be sent to confirm the withdrawal.

Please note that without a formal email of withdrawal, a manuscript is not considered withdrawn and use of such a manuscript elsewhere will be construed as ethical misconduct.

ARCHIVING AND REPOSITORY POLICY

To ensure the preservation of published scholarly articles, Allied Medical Research Journal has implemented a comprehensive archiving and repository policy. The journal pledges to preserve metadata through LOCKSS (it should go to this URL <http://ojs.amrj.net/index.php/submissions/gateway/lockss>) and CLOCKSS (it should go to this URL (<http://ojs.amrj.net/index.php/submissions/gateway/clockss>) via PKP PN, Google Scholar, and self-repository. Furthermore, AMRJ guarantees that all published scholarly articles will remain available in its self-archived account even after an accidental loss of journal data. The journal is continuously adding data to well-known repository services.

As an Open Access Journal, Allied Medical Research Journal grants authors the right to make their articles publicly available in accordance with the terms of the CC BY license. The Creative Commons Attribution License allows any scholar to share or copy the work with proper referencing to the original author. However, scholars who adapt the work are restricted from using statements like 'all rights reserved' or any other statement that would assume ownership of the work.

For published articles, a link to the journal's home page or articles' DOI and URL has been set. Entire volumes in the form of PDFs are uploaded to journal's website after an embargo period of 0 months after publication.
